#### Description of necessary first aid measures

### 5. Fire-fighting measures

## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

**For non-emergency personnel** Keep unnecessary personnel away. Wear appropriate protective equipment and clothing during clean-up. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained.

**For emergency responders** Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

**Environmental precautions** Avoid release to the environment. Contact local authorities in case of spillage to drain/aquatic environment. Prevent further leakage or spillage if safe to do so. **Methods and materials for containment and cleaning up** Large Spills: Stop the flow of material, if this is without risk. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. For waste disposal, see Section 13 of the SDS. Clean up in accordance with all applicable regulations.

**Conditions for safe storage, including any incompatibilities** Keep container tightly closed. Store in a cool and well-ventilated place. Store away from incompatible materials (See Section 10).
