### 4. First-aid measures

#### Description of necessary first aid measures

<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if any discomfort continues.
<b>Skin contact</b>	Take off immediately all contaminated clothing. Chemical burns must be treated by a physician. Wash contaminated clothing before reuse. Get medical attention immediately.
<b>Eye contact</b>	Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention immediately.
<b>Ingestion</b>	Rinse mouth. Do not induce vomiting. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Get medical attention if any discomfort continues.
<b>Personal protection for first-aid responders</b>	Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves.
<b>Symptoms caused by exposure</b>	Rash. Corrosive effects. Symptoms may include stinging, tearing, redness, swelling, and blurred vision. Permanent eye damage including blindness could result.
<b>Medical attention and special treatment</b>	Provide general supportive measures and treat symptomatically. Symptoms may be delayed. Chemical burns: Flush with water immediately. While flushing, remove clothes which do not adhere to affected area. Call an ambulance. Continue flushing during transport to hospital.

### 5. Fire-fighting measures

#### Extinguishing media

## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

**For non-emergency personnel** Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained.

**For emergency responders** Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

**Environmental precautions** Avoid release to the environment. Do not discharge into drains, water courses or onto the ground. Environmental manager must be informed of all major releases.

**Methods and materials for containment and cleaning up** Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

**Other issues relating to spills and releases** Never return spills in original containers for re-use. For waste disposal, see Section 13 of the SDS. Clean up in accordance with all applicable regulations.

## 7. Handling and storage

**Precautions for safe handling** Do not breathe mist or vapor. Do not get in eyes, on skin, on clothing. Persons susceptible for allergic reactions should not handle this product. Use with adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.

**Conditions for safe storage, including any incompatibilities** Keep container tightly closed. Store in a cool and well-ventilated place. Store away from incompatible materials (See Section 10).
