#### **SECTION 4: FIRST AID MEASURES**

#### 4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

#### By inhalation:

# 6.1 Personal precautions, protective equipment and emergency procedures:

#### For non-emergency personnel:


