LATICRETE Europe products are warrantied to comply with the Construction Products Regulation (CPR) No. 305/2011 and the European Norms (EN) standards currently in force.

For this limited warranty to apply, the applications that comprise the installation must be performed with the products listed in this document for each application (refer to chart). Please refer to individual product data sheets for specific guidelines.

Notwithstanding the previous paragraphs, exterior facades with ceramic tile, stone, adhered masonry veneer, or thin brick installed over substrates with steel or wood framing do not qualify for this limited warranty.

Notwithstanding the previous paragraphs, ceramic tile, stone or quarry/packing house tile installed in commercial and industrial kitchens do not qualify for this limited warranty.
