




4. FIRST AID: EMERGENCY PROCEDURES

Eye Contact	:	Rinse immediately with plenty of water also under the eyelids for at least 20 minutes. Remove contact lenses.
Skin Contact	:	Immediately remove contaminated clothing, and any extraneous chemical, if possible to do so without delay. Wash off immediately with plenty of water for at least 20 minutes. NOTE TO PHYSICIANS: Application of corticosteroid cream has been effective in treating skin irritation
Inhaled	:	Move to fresh air
Swallowed	:	Never give anything by mouth to an unconscious person. Prevent aspiration of vomit. Turn victim's head to the side.

5. <u>FIRE FIGHTING MEASURES</u>

Suitable extinguishing media	Alcohol-resistant foam Carbon dioxide(CO2) Dry chemical Dry sand Limestone powder
Specific hazard	Incomplete combustion may form carbon monoxide. Burning produces noxious and toxic fumes. Downwind personnel must be evacuated.
Special protective equipment for fire- fighters	Avoid contact with skin. A face shield should be worn. Use personal protective equipment. Wear self-contained breathing apparatus for firefighting if necessary.
Further information	Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations. Do not allow run-off from firefighting to enter drains or water courses.

Environmental precautions: construct a dike to prevent spreading

Methods for cleaning up: approach suspected leak areas with caution. Call emergency response number for advice. Place in appropriate chemical waste container.

7. HANDLING AND STORAGE

Handling: Avoid contact with eyes. Emergency showers and eye wash stations should be readily accessible. Adhere to work practice rules establish by government regulation. Use personal protective equipment. When using do not eat, drink or smoke

Storage: keep away from oxidizers. Keep containers tightly closed in a dry, cool and well-ventilated place. Keep from freezing Storage temperature: 50-95°F (10-35°C)


8. <u>EXPOSURE CONTROLS AND PERSONAL PROTECTION</u>




