4. FIRST AID: EMERGENCY PROCEDURES

Inhalation: Move into fresh air and keep at rest. If breathing stops, provide artificial respiration. Get medical attention if any discomfort continues.

5. FIRE FIGHTING MEASURES

Fire fighting equipment/instructions: In case of fire and/or explosion do not breathe fumes. 6. ACCIDENTAL RELEASE MEASURES
